Land Use and Planning Resource Reports to Minnesota Legislature (LUPR)

- Completed final report in January 2011 and three progress reports. http://www.metrocouncil.org/planning/LUPR/index.htm
- Staff met with land use and transportation advisory committees for the Council to help meet a legislative requirement of collaborating with local units of government and other stakeholders.
- Reports address legislative goals of reducing air pollution, mitigating congestion and reducing
 infrastructure costs. The final report covers policies and strategies, resources and tools, 2030
 comprehensive plans, a tool to estimate travel-related air pollutants, outreach efforts, and an assessment
 of outcomes and lessons learned.

Open space and natural resources

• Economic analysis of open space premium in Hennepin County; presentation on Natural Resources Qualitative Assessment Report; and demonstration of Natural Resources Digital Atlas.

Follow-up on 2001 fiscal impact study

- Made recommendations to CDC and the Council to: (1) evaluate and develop cost-specific measures to support or justify regional services; (2) recognize costs of maintaining and replacing infrastructure; and (3) provide an inventory and evaluation of available land supply for development and redevelopment.
